Result of National Overseas Scholarship (NOS) for SC etc. candidates from Grievances received for the Selection Year 2024-25

As per Clause 8(e) of the NOS scheme guidelines, a period of up to 30 calendar days from the publication of the results on the portal is provided for the submission of grievances in connection with the Results. During this period, 45 grievances were received. Out of these grievances, 03 were found to be genuine and the matter was thus placed before the Selection-cum-Screening committee. The Committee in its meeting held on 03.09.2024 has recommended the selection of candidates whose grievances were found to be genuine, subject to the availability of slots and compliance with eligibility criteria. After recommendation of the Selection-cum-Screening committee the matter was placed before the Competent Authority who has approved that these candidates be selected against vacant slots due to withdrawal/cancellation of scholarship from the candidates provisionally selected for Award during the First Cycle of Selection Year 2024-25. Keeping in view the QS ranking and the State Quota, the following has been approved by the competent authority:

- i. 02 (two) candidates have been provisionally selected from the grievances received for the Award of scholarship at Annexure-I, against the 02 vacant slots of S.Y. 2024-25;
 - ii. 01 (one) candidate has been placed in the second list, i.e., the non-select list on the basis of QS ranking and State Quota.
2. The candidature of the selected candidates is **PROVISIONAL** subject to being found eligible in all respects. The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, caste, denotified, nomadic and semi nomadic tribes certificate, landless agricultural labourers and traditional artisans certificate, income etc. before actual release of funds under the scholarship award. The selection would be confirmed subject to verification of all original documents and fulfillment of the other eligibility requirements as per scheme guidelines.

3. Provisional Award letters will be issued to selected candidates shortly. The selection would only be confirmed after the verification of all original documents and fulfillment of the other eligibility requirements like Submission of Bonds, Confirmation of admission, accreditation of college/ university by Indian Missions abroad etc. as per scheme guidelines. The provisional Award letter however, will not bestow any legal right on the candidate to claim the award and the award will be cancelled if any information/ documents submitted by the candidate is found to be false/ incorrect. Further, if he/she has availed scholarship or is availing scholarship under NOS, action will be initiated for recovery of the scholarship disbursed as per the extant guidelines of the scheme. Such candidate is also liable to be black listed for future.
